RULES AND REGULATIONS

Eligibility: The sweepstakes is offered in the United States and open only to U.S. citizens and permanent residents of the United States who at the time of entry are at least 18 years of age and who have a valid driver’s license. The sweepstakes shall be construed and evaluated according to the law of the 50 United States and D.C. Do not enter if you are not eligible. Sweepstakes Period: Giveaway begins on August 1, 2026, at 12:00:01 a.m. CST. Giveaway period ends on October 31, 2026, at 11:59:59 p.m. CST

TO PARTICIPATE AND SUBMIT ENTRIES

To Enter the Contest: An eligible Registrant must electronically register by uploading an entry. The entry period opens at 12:00 a.m. CST on August 1, 2026. At that time, all eligible persons are invited to participate in the Win a Trip Giveaway. All entries must be uploaded by the close of 11:59 p.m. CST on October 31, 2026.

Entries may only be submitted by a single, eligible Registered User.

About Entries: Entries must be received during the entry period. No other form of participation is valid; no mail-in entries will be accepted. Each entry may be screened by a representative of Sponsor for compliance with these official contest rules. Sponsor reserves the right to disqualify contestants. Fraudulent activities will be monitored and will lead to disqualification.

Selection of Winner: A random drawing for the Grand Prize from among qualified entrants will take place on or about November 1, 2026. To be declared a winner, World of Asphalt (whose decision is final and binding on all aspects of the Giveaway), must first confirm the selected entrant’s eligibility. If a selected entrant is deemed ineligible at the time of the drawing, an alternate entrant will be selected from among all remaining eligible entrants. Attendance at the drawings is not required to be declared a winner. If a winner cannot be notified within fifteen days after drawing, or in the event of a selected entrant’s non-compliance with any of the requirements of these Official Rules, the prize will be

forfeited. A winner is free to decline a prize and World of Asphalt may select an alternate winner under these circumstances, at World of Asphalt's option.

Contest Prizes: All eligible entries submitted will be entered into the contest. Two (2) "Win a Trip Giveaway" winners will be randomly selected by Sponsor to receive the following Grand Prize:
